## Cookies Policy


### 1. What is a Cookie?

Cookies are small text files that are saved on your computer or mobile device by the websites or applications that you visit. Cookies are then sent back to the originating website on each subsequent visit, or to another website that recognizes that cookie. Cookies may store user preferences and other information. The use of cookies is now standard for most websites. If you are uncomfortable with the use of cookies, you can manage and control them through your browser, including removing cookies by deleting them from your 'browser history' (cache) when you leave the site. However, some website features or services may not function properly without cookies.

We use the term “cookies” throughout this Cookies Policy to also cover similar technologies such as Software Development Kits (SDKs).

Targeting cookies	Targeting cookies may be set through our site by our advertising partners. They record your visit to our website, the pages you have visited and the links you have followed. We will use this information to make our website and the advertising displayed on it more relevant to your interests. We may also share this information with third parties for this purpose. If you do not allow these cookies, you will experience less targeted advertising.
